Known issues

The following section lists an overview of known issues in this release.

- On iPad, scrolling a form while the keyboard is open results in not being able to scroll all the way to the top or bottom of the form. (PC-89799)
- Inputting a document property or custom property through barcode scanning may not save. (PC-89718)
- Some images captured in the Android mobile shell may appear rotated. (PC-89770)
- Mobile capture of a document with a custom property with a very large number of diacritical marks may silently fail. (PC-89771)
- Stale workflow data may cause an issue in workflow module where a user must log out to refresh the workflow grid. (PC-89780)
- Unable to send a document through email. (PC-89789)
- On Android, adding pages to an existing document, using the Add Pages button, fails. (PC-89808)
- On iOS, you may encounter issues when reordering document pages. Attempts to reorder may incorrectly display the iOS context menu for the image you are attempting to reorder. (PC-89809)
