- Added a new configuration property, show-search-controls, to the lesrdl-content-views section of the config.json file. This property specifies whether to display or hide the filter controls in the Views grid. (PER-7338)
- Resolved an issue with OIDC authentication flow when configuring the clientSession setting to les-rdk-fpa-mobile-context:IdpClientSession in Hyland Mobile 1.5 and later. (PER-7185)
- Resolved an issue in Experience Mobile with forms not loading on an initial attempt. (PER-4701)
- Resolved an issue where the lesrdl-content-integration server OidcClientSession property did not correctly match the callback URL. (PER-7048)
