- Perceptive Transcript eForm now supports multiple document types. (HEDPRO-70)
- Besides using an applicant's subject, institution ID, and course ID, you can also use college codes to perform an equivalency check on the course. (HEDPRO-71)
- Perceptive Transcript eForm now enables you to store an institution ID either as an index key or a custom property. (HEDPRO-26)

- In Joint Services transcripts, new fields such as "Start Date", "Credits", "Credit Area", and "Level" are added. (US 35369, US 35360, US 35359)

- In High School transcripts, SAT scores, ACT scores, and Other scores can now be exported from Perceptive Intelligent Capture. (US 35370)

- The ACT score tooltip is updated with the new score range. Under SAT scores, in the "Date" field, the day is no longer required and in the Total field, the value is automatically calculated. (US 35368)

- Added a check box to select course work for course equivalency and SIS upload. (US 60358)
- Added the GPA field to the Transcript eForm. (US 56314)
- Added user-defined fields to the transcripts. (US51826)
- Added user-defined fields to the Course Equivalency review form. (US 56316)
- Added support for Invalid Reason code routing. (US 57342)
- Enhanced the system to concatenate student name in a configurable way. (US 57345)
- Included institution ID in the same custom property in one place irrespective of the transcript type. (US 57346)
