Enhancements

The following enhancements are included in this release.

- Added three configuration properties, Start TLS, Encryption Protocols, and Check Server Identity. Start TLS specifies that eAuthorize enables TLS encryption using an existing unencrypted connection with the mail server. Encryption Protocols specifies the list of supported protocols with which to negotiate when connecting to the mail server. Check Server Identity enforces certificate validation when connecting to the mail server. (PC-90184)
- Replaced the Windows installer with iScripts to create the Perceptive Content components. (PC-90184)
- eAuthorize now requires Perceptive Content 7.3 or higher. (PC-90184)
- eAuthorize now supports Perceptive Connect Runtime (PCR) 2.0. Previous versions of PCR are no longer supported. (PC-89452)
- Removed passwords from the List Component and List Services pages on PCR. (PC-90132)

Enhancements

The following enhancements are included in this release.

- In eAuthorize the existing Envoy and Perceptive Integration Engine (PIE) based web service components are replaced with a Perceptive Connect Runtime (PCR) based connector. The PIE is replaced with Perceptive Connect Runtime framework. The SubmitForSignature, SendToAssureSign and DownloadSignedDocuments ASQ operations are implemented in the new PCR bundles. - eAuthorize currently supports HTTPS communication. (US106158)

- The AssureSign operations are implemented in the new PCR bundles. (US102600)
- You can configure Connect ASQ for Perceptive Content 7.1.5 or higher. (US104700).
- You can configure AssureSign parameters and Email parameters in the eAuthorize Configuration page of the Perceptive Connect Runtime dashboard. (US105799)

Perceptive eAuthorize Patch (February 11, 2013)

Perceptive eAuthorize is a solution that enables you to send documents for electronic signature to any authorized signatory, including non-ImageNow users.

- You can now store both the original document and the signed document separately, rather than the signed document always replacing the original. (US 16115)
